### Hall County 2024 Property Taxes Due by Nov. 15

**GAINESVILLE, Ga (November 1, 2024)** As the November 15 property tax deadline approaches, the Hall County Tax Commissioner's Office wants to remind taxpayers of the convenient options available for paying taxes—designed to save time and reduce the need for in-person visits.

"We've been focused on providing multiple payment methods so taxpayers can avoid coming into our office," said Hall County Tax Commissioner Darla Eden. "Now, the only reason to visit is for cash payments."

Through a revamped website and other outreach efforts, the Tax Commissioner's Office is promoting its "Save a Trip and Skip the Line" campaign. For more information, visit [hallcountytax.org](http://hallcountytax.org), where you can also find a brief video overview of the 2024 Property Tax Season and simple instructions for online payments.

Paying your property taxes online at [hallcountytax.org](http://hallcountytax.org) is straightforward, secure, and convenient. Payment options include E-Check for a flat fee of \$1.50, debit card with a 1.50% transaction fee, and credit card with a 2.49% fee. All major credit cards are accepted, and PayPal Credit offers an interest-free line of credit if paid in full within six months, subject to terms and conditions.

You can also pay by mail using the return envelope provided with your tax statement. Simply send your check or credit card information to P.O. Box 1579, Gainesville, GA 30503. Ensure your payment is postmarked by November 15 to avoid state-mandated interest charges.

For added convenience, there's a 24/7 drive-up drop box located across from the front doors of the Hall County Government Center at 2875 Browns Bridge Road. Payments must be submitted in the drop box on or by Nov 15 to avoid state mandated interest.

Payments can be made via debit and credit card through the Customer Interaction Center, with agents available Monday to Friday, from 8 a.m. to 5 p.m. For assistance or to make a payment, call 770.531.6950, text 833.602.8497, or email [propertytax@hallcounty.org](mailto:propertytax@hallcounty.org).

In-office cash payments will be accepted at one of the Tax Office lobby windows, while checks and cards transactions may be processed at the Information Desk located just inside the entrance of the Hall County Government Center.

Property owners as of January 1 are responsible for that year's property tax. For properties sold in 2024, it's essential for buyers and sellers to clarify who will pay the tax by the November 15 deadline. Please refer to your closing documents or consult your attorney to confirm tax liability and ensure timely payment.

"Our office is committed to providing a variety of payment options that meet the needs of our community," said Eden. "I encourage property owners to take advantage of our many convenient tools to save a trip and skip the line."
